## **Application Procedure**

A non – refundable registration fee of Rs.1000/- for each item for registration for the year 2025 should be made by prospective supplier and this fee may be paid in cash cashier, Industrial Development Board of Ceylon or by a cheque drawn in favor of Industrial Development Board of Ceylon.

The application should be forward along with the payment receipt / Cheque under registered post or delivered by hand, indicating "Registration of Suppliers for the year 2025" on the left hand corner of the envelop, to reach the Chairman, Industrial Development Board of Ceylon No: 615, Galle Road, katubedda, Moratuwa on or before 11/12/2024.

Applicants who wish to register for Building Construction and Maintenance should possess the membership of the Association of Construction Contractors of Sri Lanka & National Registration of CIDA for Building Construction. They are further requested to submit valid copies of those documents together with their application.

One Application Form can be used to register for supply of multiple products/ Services by paying registration fee for all items at the same time. Incomplete and late application will be rejected.
